OBJECTIVE



Bottom-up analysis strives to identify stocks trading at discounts to intrinsic value, companies with attractive long-term growth rates, and those poised to benefit from catalysts such as positive revenue, cash flow, and earnings growth.

The strategy employs a concentrated allocation approach, can invest in companies across all market capitalizations, and is not constrained by sector concentration limits.


